

FS Pro Tour Agricultural Demo Day – Terms & Conditions & Indemnity Agreement

1. General Terms

- 1.1. By purchasing, taking possession of a ticket or entering the area to the **FS Pro Tour Agricultural Demo Day** ("Event"), the ticket holder ("Attendee") agrees to these **Terms & Conditions**.
- 1.2. The Event is organized by **Farmspace (Pty) Ltd** ("Organizer") and will take place at **the chosen venue on ticket date**.
- 1.3. The Organizer reserves the right to change the schedule, venue, or cancel the event at any time due to unforeseen circumstances.
- 1.4. **IMPORTANT NOTE:** Clauses 5 and 6 are important. They make you take on liability and risks and take away your rights and remedies. They also limit and exclude our liability and responsibilities.
- 1.5. These Terms and Conditions as governed by the laws of South Africa will only apply as far as is allowed by the law. These Terms and Conditions must be interpreted so that they will not break the law and must be applied as far as the law allows.

2. Ticket Policy

- 2.1 Tickets will not be refundable if an event is cancelled or postponed for any reason.
- 2.2 Lost or stolen tickets will not be replaced.
- 2.3 Tickets are not transferable between individuals.
- 2.4 Admission is granted only by a valid ticket holder.
- 2.5 You may not buy or obtain a ticket with the intention to sell, transfer or use such ticket or any rights pertaining to such ticket, whether for profit or not.
- 2.6 You may not directly or indirectly sell, dispose of or promote a ticket or any right relating to such a ticket. Farmspace Ticket is the only official ticketing platform.
- 2.7 The Organizer is not responsible for tickets purchased through third-party sellers and those tickets will not grant entry or be accepted at the entrance.

3. Access for minors

- 3.1. All children need a valid ticket to enter the event (pricing remains the same as an adult ticket).
- 3.2. Children under the age of 18 require adult supervision and will not be allowed to consume alcohol.

4. Disabled Persons Access

- 4.1. As the event is hosted in an open field it is not equipped for disabled persons.
- 4.2. Disabled persons requiring specific access must contact the event organizers in advance to enquire if this is available.

5. Indemnity & Liability Disclaimer

The Company, its officials, agents, representatives and employees will not be liable or held responsible to you or anybody else for any loss, injury or damage of whatever nature and however arising from or in connection with any of the following:

- 5.1. Any FS Pro Tour Agricultural Demo Day event.
- 5.2. The cancellation or postponement of any event.
- 5.3. Theft, damage or loss of any personal property.
- 5.4. Damage to, or theft from, or theft of any vehicle or any of its contents.
- 5.5. Death or personal injury.
- 5.6. The actions or omissions of any person.

6. Event Rules & Safety

- 6.1. No unauthorized entry: Attendees must hold a valid ticket and comply with security and access control procedures.
- 6.2. No Smoking: Adherence to all regulations for smoking within South Africa has to be adhered to. Smoking Areas will be designated away from the normal event areas.
- 6.3. Unauthorized entry into the demo area and equipment parking area is strictly prohibited during demo times.
- 6.4. Prohibited behaviour: You are not allowed to behave in any way which is a nuisance, violent, abusive, disruptive, threatening, an infringement of somebody's rights, or which we reasonably consider to be inappropriate or unacceptable.
- 6.5. Alcohol consumption:
 - 6.5.1. Attendees must be 18 years or older to consume alcohol.
 - 6.5.2. The Organizer reserves the right to deny service to any intoxicated person.
- 6.6. Dangerous items are not allowed at the event this will include but not be limited to explosives, illegal substances, hazardous objects or any item that could place other attendees or the organizer in danger by normal use or misuse.
- 6.7. No illegal firearms are allowed. If firearms are carried, the person must be able to present a valid firearm license.
- 6.8. Medical & Emergency Services will be available on-site, but attendees are responsible for their personal well-being.

7. Photography & Media Release

7.1 By attending the Event, Attendees grant the Organizer permission to photograph, film, and use images for promotional purposes.

7.2 If an Attendee wishes to opt-out, they must notify the Organizer in writing before the event.

7.3 The **event premises are under 24-hour surveillance.**

8. Protection of Personal Information

8.1 When purchasing a ticket, Attendees agree to the event's **Privacy Policy.**

8.2 Personal data will be processed **in compliance with privacy laws.**
